

Via this **ADDENDUM**, [●], an entity of [●] nationality, with registered address at [●], with company number [●], and [Meliá Hotels International, S.A. or Hotel XXX], an entity of [xxxx] nationality, with registered address at xxxx, agree to include this clause in the contract of the group xxxx with arrival date xxxxx

Additional clause: Epidemic outbreak of an infectious and contagious illness

1. Notwithstanding anything to the contrary set out in this contract, the [Meeting Planner] may at any time cancel the reservation made via this contract with respect to a hotel establishment if, due to an endemic outbreak of an infectious and contagious illness (except for the annual influenza and any illness against which an authorized vaccine exists) and after the signature of this document:
 - a) an order of a competent public government or sanitary authority imposes restrictive measures regarding the circulation or concentration of persons or restricts in any other way the normal functioning of the activity in the municipality or locality where the hotel establishment affected by the respective reservation(s) is located (e.g. the prohibition of the celebration of events, the closure of certain public spaces or travel prohibitions) and the date(s) of the respective reservation(s) coincide(s) with the temporal scope of the implementation of the respective restrictive measures, or
 - b) the competent public sanitary or government authority of the municipality, autonomous region or country confirms the existence of such outbreak in the municipality or locality where the hotel establishment affected by the respective reservation(s) is located even though such authority does still not take any of the measures described under limb "a)" above and the [tour operator] provides sufficient proof to the [hotel operator] that its end clients have cancelled vis-à-vis the [tour operator] more than [70%] of the reservations that correspond to the reservations that the [tour operator] desires to cancel in accordance with this limb "b)", or
 - c) [Optional if expressly required by, and agreed with, the tour operator:] *[an order of a competent public government or sanitary authority imposes restrictive measures regarding the circulation or concentration of persons or restricts in any other way the normal functioning of the activity in the municipality or locality where the end clients affected by the respective reservations are domiciled and make the transport of such end clients from their domicile to the hotel establishment impossible at the scheduled dates, or]*
 - d) the following event organized by third persons at the municipality or locality of the affected hotel establishment is cancelled: *[Insert name, place and dates of the third-party event]*.
2. If the [Meeting Planner] cancels the group or event in accordance with any of the situations set out in paragraph 1 above, then the respective damages or penalty or retention of any deposit made by the [Meeting Planner] which could otherwise derive from such cancellation in conformity with this contract will not apply. The foregoing sentence notwithstanding, the [Meeting Planner] before proceed with the cancellation shall explore the possibility of postpone the event to new dates within the current year or move it to another property from Melia Hotels International portfolio.
3. The foregoing assumptions detailed in paragraph 1 of this annex notwithstanding, this paragraph 1 will only apply if and to the extent the [Meeting Planner] notifies the respective cancellation to the [hotel operator] within the period of time when the sanitary emergency is activated

Except to the extend this addendum amends the contract, the parties hereby ratify the content of the contract as of today.
