REOPENINGS

Since June 15

Restaurants and cafés – Open

Internal borders to the European area - Schengen area.

From 1 July

Gradual opening of the external borders to the EU-Schengen area.

From September 2020,

and subject to a new assessment of the epidemiological situation

Opening of establishments hosting fairs, exhibitions and shows.

Gatherings of more than 5 000 people authorized starting October 30th

Since 2 June, the Government has made public a poster "*Notre établissement s'engage*" which all professionals can display at the entrance of their establishment, provided that they have put in place the measures and recommendations to ensure the safety of all.

FRENCH DESTINATIONS AND ESTABLISHMENTS INVOLVED IN HEALTH MEASURES

French cities and service providers are committed to the public.

In addition to the recommendations at the governmental level, referential, labels and certifications are be set up by French service providers and destinations. Their objective is to ensure the safety of visitors in terms of health and to reassure them that they will be welcomed in the best possible conditions in France.



HEALTH RECOMMENDATIONS FOR THE EVENTS SECTOR

Approved by the French Government

1- Site access regulations

- Social distancing of 1m between every individual
- Checking/control of admissions upon arrival with an entrance/exit counting system in place
- Masks and sanitising gel widely available
- Presence of trained reception staff to ensure that "barrier" measures are followed by the general public

-2- Information for participants, exhibitors and visitors to ensure they are fully aware of regulations in place:

- Ensure communication prior to and during the event
- Main principles: social distancing, wearing of masks, hand hygiene

3- Determine the conditions necessary for the setting up and dismantling of an event

- Staggering of operations
- Encourage the coordination of some operations off-site
- Compulsory wearing of PPE (masks, visors, gloves...)
- Extend wherever possible the length of set-up/dismantling operations



4- Implementation of social distancing

-Floor markings and organisation of flow of visitors (separate entrances/exits), adapting of routes as required (e.g. at bottlenecks)

-One-way staircases or arrows indicating direction for climbing/descending stairs - information on the maximum authorised capacity for lifts.

5- Stepping up of hygiene measures and limiting points of contact

-Encourage non-contact solutions (online ticketing, contactless payments, printing of badges at home, ordering of meals, online menus)

6- Introduction of layout changes and flow management in specific areas

-**Reception areas:** plexiglass screens, floor markings, queue management, provision of appropriate PPE for staff

-**Dining areas:** regulation of flow, 1.5m² for seated diners, tables seating a maximum of 10 people, plus 1m separation between tables

-**Conference and meeting rooms / auditoriums:** reconfiguring of conference rooms: 1 in every 2 seats in a staggered layout; reconfiguring of group spaces: hygiene measures and 1m spacing between 2 people

7- Ensure that an isolation area is available to medical staff if a participant shows symptoms on-site
